1. Contact the emergency services immediately.
2. Take photographs of all vehicles involved, to show the damage and location on the road.
3. Record all vehicle registrations and driver details.
4. Note the Police reference number and witness details.
5. Contact O'Reilly Stewart via telephone or the ORS App. You will receive an advice from a Solicitor within 1 hour.

**Upon receipt of instructions, we will explain, at NO cost to you, how all issues relating to the accident will be resolved.**

**In particular we will:**

- Liaise with all Insurance Companies & PSNI
- Assist with Bike damage & outlay recovery
- Arrange Accident Reconstruction
- Recover compensation for injuries and medical treatment or rehabilitation costs
- Recover present and future loss of earnings
